The Institute for Justice and Reconciliation (IJR) was launched in the year 2000, in the aftermath of South Africa's Truth and Reconciliation Commission. The aim was to ensure that lessons learnt from South Africa's transition from apartheid to democracy were taken into account as the nation moved ahead. Today, the Institute helps to build fair, democratic and inclusive societies across the African continent, through carefully selected engagements and interventions.

About the IJR Reconciliation Award

Each year the IJR confers the Reconciliation Award to an individual or organisation that has outstandingly contributed to nation-building and reconciliation in South Africa. The Award is intended to highlight and celebrate recipients' approaches to enabling reconciliation, while inspiring others to play their part in helping to build a reconciled country.

In commemoration of Nelson Mandela's legacy, the *Living Reconciliation* theme of this year's Award aims to celebrate the progress and deepening of reconciliation in South Africa over the past 20 years. To this end, the IJR issued a public call for nominations in June 2014, which set out to identify individuals and organisations that worked to unite people from different backgrounds, by creating spaces for dialogue and sharing.

The broad concept of reconciliation is defined as follows for the context of the Award:

Reconciliation strives to go beyond the normal, recognising that a failure to set in motion programmes to address sources of conflict which include the demand for retribution, acknowledgement, reparations, poverty relief and access to land will result in little more than delayed violence. It therefore involves taking the first steps to achieving the higher goal of sustainable peace. Reconciliation requires restraint, generosity of spirit, empathy and perseverance. This difficult task is sustained and energised by concrete goals, and a shared vision of what can and might yet be accomplished.

RECIPIENT

Partners for Possibility (PfP) is the flagship programme of Symphonia for South Africa – a national non-profit organisation, based in Bellville, Cape Town, with the bold vision of realising quality education for all children in South Africa by 2022.

PfP was founded in 2010, when founder and director of Symphonia for South Africa, Louise van Rhyn, became the first business leader to partner with a school principal, in an effort to improve the school's education outcomes.

PfP is driven by the idea that enhancing the quality of education, improving the school environment and encouraging engagement between parents and teachers are attainable goals towards meaningful societal development. By placing the school at the centre of community, PfP believes that a radical transformation can be achieved in the education sector.

To date, the PfP model has been implemented in 180 schools nationwide. Over 6 800 teachers, 140 000 parents and 136 000 learners have been impacted. The programme has been supported by over 100 South African corporate and medium-sized enterprises.



In the spirit of this year's Reconciliation Award theme of *living reconciliation*, Partners for Possibility is recognised for enlivening reconciliation by helping to bridge the social, economic and geographical divides between the business and education sectors.





I subconsciously assumed that there was a correlation between poverty and lack of goodwill. I did not realise I carried this prejudice until confronted with the reality of my peers in the Partners for Possibility Programme. My social interactions assumed that principals, teachers and pupils were destroying books and not attending school because somehow they didn't care. I feel honoured to have had my unspoken assumptions obliterated. I have never come across such commitment, goodwill and effort by people to build their communities. I realise that my own commitment to my country has been weak – not theirs.
